The exhibitor, who is named on the application (including staff associated with the exhibitor), must attend the tables reserved in his/her name, and is responsible for following the show rules of conduct including federal and local regulations. Show staff and Security can at any time remove you and your belongings if found in violation of regulations, and at no refund to you. Crocodile recognizes the need for some exhibitors to break down prior to the close of the show, we ask that you remain in place the entire show hours as a courtesy to the paying public. No subletting of tables. No sales to anyone under the age of 18 unless permitted by parent or guardian. No animals allowed other than service animals. Electrical services may come at an additional charge, based on facility. Crocodile has the right to request payment for no show, no call vendors before being allowed to book future tables. Crocodile is not responsible for any lost or stolen items. Crocodile has the discretionary power to remove unacceptable items from sales and display tables. All Firearms must be unloaded at all times and secured with a zip-tie., only law enforcement & security is not prohibited from having a loaded weapon.
